3. ZOOM

The group agreed that the aim of the project would be to target new audiences, particularly householders and involve them recording bumblebee sightings. As well as raising awareness the project would provide useful information to both TBP and organisations further afield e.g. Bumblebee Conservation Trust (BBCT).
