2. Minutes of previous meeting were agreed. **Matters Arising**

a) Dundee Bat Project - CL reported that the training sessions organised had gone well. There are further training sessions being planned for later in the year.

Priority Actions- updates 3.

USG1 – Urban Red Squirrel Initiative i)

AA updated the group on the proposal from the Forestry Commission to support a Tayside Red Squirrel Project, FCS has approached the Dundee Red Squirrel Project to discuss widening the existing project out to cover Tayside. The project would be up and running as soon as possible to support existing work and partnerships, with the aim of encouraging additional action for red squirrel conservation.

The group asked that those already involved in squirrel work in P+K and Angus be consulted before the project progressed. AA assured the group that this would happen and Ken Neil from Dundee would be contacting relevant people.

ii) **USG2 – Acoustic Ecology**

AL is organising 6/7 afternoon sessions for late June. The project will be very process orientated with representatives from a diverse range of groups (Art Angel / Naturalists / Scientists / Audio Artists / Poets / Bat Project etc) taking part. The Nature Nutters will be participating during the first week of July. A public event is planned for 12th August.

USG3 – Greenspace, Community Gardens and Allotments iii)

CL will be drafting a booklet on the Glasgow version in August / September. P+K and Angus Councils and SNH will be contributing to the leaflet. The group agreed that the draft should be sent out for consultation with local groups and that CL would also send it to Gordon Robbie.

USG4 – Urban Grassland Management iv)

CL reported that there are two courses on grassland management in Tayside.

- a) Flora Locale 21st June Scotia Seeds Brechin
- b) TBP at the Living Field Study Centre, SCRI 26th June

The group recognised the importance of 'people on the ground' attending the event and encouraged CL to 'twist arms'.

The group discussed locations for trial management areas. AA was keen to see demonstration / trial plots in Dundee, JW suggested Trottick Ponds / AA Dawson Park. Also likely that a demonstration area will be set up at Forfar Loch.

v) USG5 - Invasive Species Project

Baldovan House - PC reported that the planning application for the development of part of the Baldovan House had been approved. A section 75 agreement will cover the invasive species contained within the planning application site (which is only a proportion of the whole site). The section 75 agreement covers surveying the extent of Giant Hogweed / Himalayan Balsam and Japanese Knotweed and their ongoing control.

Control of invasive species on the remainder of the site also needs to be addressed. The Esmee Fairbairn Trust may fund this type of project.

USG7a - ZOOM / Bumblebees

AA/AL met to discuss project. Proposal to base approach around ZOOM. General public encouraged to report sightings of bumblebees in Tayside.

- c) Bumblebee pack will have free gift of eg candle, beeswax lip balm etc as well as information / id quide / survey sheet etc. CD offered 500 of SNH Bumblebee book for pack.
- d) Bumblebee pack also distributed to existing groups etc eg Allotment Organisation / Barnhill Rock Garden.
- e) participants send back survey sheet / put info on net etc
- f) follow-up if necessary

Costs: Postcards approx £700 for design / printing / freepost licence for 2,500 postcards. Bumblebee packs approx. £3.50 - £5.00 per pack. Sources of funding to be investigated.

Timing: organise for next spring 2008.

Management: AL reported that BFEP would be willing to manage the project, but would have to gain agreement from BFEP management group. AL to investigate.
